The total number of electors after the Summary Revision – 2008 is 17,18,023 (Males – 8,26,186 & Females – 8,91,837)
(b) the progress made in percentage of the preparation of the electoral Photo-ID card A/C-wise?	(b) As on date, no Electors Photo Identity Cards (EPICS) are prepared as per the revised Guidelines – 2000 & subsequent instructions of Election Commission of India. However, preparation for Photo Electoral Rolls (Electoral Rolls with photograph of the elector) for all 60 (sixty) ACs are currently in full swing.
