**AMENDMENT TO THE MOTION OF THANKS TO THE  
GOVERNOR'S ADDRESS TO BE MOVED IN THE HOUSE**

(1) **Shri Radhabinod Kojiam, MLA**

1. The Address lacks statement of clear policy formulations and programmes to translate the policies into actions.
2. The Address is vague on important issues being without specific data and statistics.
3. The Address is silent on the failure of P.D. System and resultant sufferings of the poor of the State.
4. The Address fails to highlight the mismanagement of Tribal Development Department in so far as the unlawful deprivation of the Tribals settled in the valley areas from the benefits of the majority of its schemes and projects.

(2) **Shri O. Joy Singh, MLA**

1. The Address fails to mention about the extra-judicial killings happening everyday thereby leading to a chaotic situation in the State.
2. The Address fails to mention about the burning problem of drug users and drug-traffickers thereby creating a serious law and order problem in the State and it also fails to spell out a clear cut policy thereof.
3. The Address fails to mention irregular power supply and acute shortage of drinking water and to bring about its time bound solution.
4. The Address fails to mention about the failure of the Government to take up and complete different works in different departments and also about the lack of proper material planning thereof.
5. The Address fails to mention about the pending payment of the entitlement of the pensioners.
6. The Address fails to mention about a clear-cut policy for protection and preservation of paddy land and wetland and to restrict conversion and reclamation thereof.
7. The Address totally fails to mention about a clear-cut policy for the protection and preservation of ecological and environmental condition of the State.
8. The Address fails to mention about the policy to control corruption while it is rampant in the State.

(3) **Dr. I. Ibohalbi, MLA**

1. The Address fails to mention clearly when and where the Loktak Protection Force was established and what is its available strength.
2. The Address fails to clarify how to improve the management of Government Schools to enhance its standards.
3. The Address fails to mention how to stop killing of Manipuris (both insurgents or civilians).
4. The Address fails to mention the sources of power even though it mentioned about the policy to improve the Power Distribution System.
5. The Address fails to mention how to stop the climate change in Manipur.
