(a) whether it is a fact that a sum of Rupees five lakh provided under SDF 2008-09 for repairing of FCS Godown at Thanlon had not been encashed and lapsed;	(a) Yes, not encashed.
(b) if so, the reasons and the list of the erring officials thereof;	(b) As per Govt. sanction order No. 6/3/2008-FCS dated 27/1/2009 for Rs. 5.00 lakhs for repairing FCS godown at Thanlon, Churachandpur, the bill No. 180/DFCS/4408 dated 28/3/2009 was prepared and signed by the DDO on 28/3/2009 and submitted to the Treasury Office, Lamphel on 30/3/2009 evening. The same was resubmitted on 31/3/2009 as delay occurred while ascertaining the appropriate Head of Account as there was no entry in the computer of Treasury for the new plan scheme. NIC was requested to enter the appropriate Head of Account in the Computer of Treasury and bill was passed on 31/3/2009. Thereafter the bill was sent to SBI, Paona Bazar on the same day by the staff of Treasury Office, Lamphel but not accepted by the Bank (SBI) as transaction was already closed and returned the bill to the Treasury Office, Lamphel.

So Planning Department will have to be moved for providing the amount only when, it is provided under State Plan 2009-10. Department will be able to make the payment.
