(a) whether it is a fact that Manipur Industrial Co-operative Bank Ltd. (MICB) was liquidated;	(a) Manipur Industrial Coop. Bank Ltd. was under liquidation process but not liquidated.
(b) whether it is a fact that a sum of Rs. 46,85,353/- sanctioned by National Horticulture Board (NHB) as subsidy for the year 2005 to the beneficiaries was withdrawn through MICB Ltd. during the period from April to November, 2005 fraudulently and misappropriated;	(b) Yes, an amount of Rs. 46,85,353/- sanctioned by the NHB for the year 2005 was reportedly withdrawn by MICB Ltd, during April to November, 2005. However, the question of fraudulent withdrawal and misappropriation thereof is subject to CBI enquiry relating to a CBI case No. RC 17(A)/107-GWH of CBI Guwahati against Shri NK. Chaurasia, the then Assistant Director (Centre In charge), National Horticulture Board and others U/s 120B, 420, 409, 468, 471 IPC under Section 13(2)r/w 13(1)(c)(d) of P.C. Act, 1988.
(c) whether it is also a fact that NHB asked the Branch Manager, MICB to return the said subsidy amount; and	(c) As CBI had seized the original files and relevant documents, this cannot be confirmed at this stage.
